**General Duties:** The Certified Community Behavioral Health Clinic (CCBHC) Psychiatrist evaluates, diagnoses, and treats patients with mental illness through a combination of personal counseling (psychotherapy), psychoanalysis, hospitalization, and/or medication. Performs initial psychiatric assessments, develops individual care plans, and implements treatment for the patient. Works as an independent psychiatric provider in the community mental health program. The position works closely with the clinical teams, collects objective and subjective data from observations, examinations, interviews, and written records in an accurate and timely manner. Documents psychiatric and medical care, collaborates with the team to carry out the plan of care, and manages outpatient medication assisted treatment as well. Orientation provided.

#### **Skill Requirements:**

- Provide clinical consultation and leadership to clinical teams
- Provide clinical consultation and support for community medical providers
- Documentation of assessments and medical care using EHR
- Submitting bill for services provided
- Review lab results with patients
- Completing and signing medical orders (meds, labs, etc.) as needed
- Assures quality of care by adhering to therapeutic standards; measuring health outcomes against patient care goals and standards; making or recommending necessary adjustments; following detox and Medical Board philosophies and standards of care set by the state Medical Board
- Recommend referrals to outside agencies as indicated
- Provide education regarding healthy recovery
- Additional duties upon approval of employee, Medical Director and BestCare Administration

#### **Tools and Equipment Used:**
